ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014

- 2. AND WHEREAS, the institution Annamalai University, Khasara No.71/1-6, 7A, B, 72/1-5, 7, 73/1-6, Street No.1, Thiruvetkulam Village, Annamalainagar Post, Chidambaram Taluk, Cuddalore District-608002, Tamilnadu has by affidavit consented to come under New Regulations and sought for 100 intake in B.P.Ed.
- 3. AND WHEREAS, it has been decided to permit the institution to have one basic unit of 100 students (two sections of 50 each) subject to the institution fulfilling following conditions namely,
